





a) with a request which must be received by the Board of Directors fifteen (15) days prior to the General Meeting (that is by 14.05.2020) and which must be accompanied by a justification or draft resolution for approval at the General Meeting, to include additional matters to the agenda of the General Meeting. The revised agenda is published thirteen (13) days prior to the date of the General Meeting (that is on 16.05.2020), in the same manner as the previous agenda.

The appointment and the revocation of a shareholder's proxy is made in writing and is notified to the Company in the same manner, at least forty-eight (48) hours prior to the date of session of the General Meeting.

Each shareholder may appoint up to three (3) proxies. However, if a shareholder holds Company shares appearing in more than one securities' accounts, this restriction does not prevent the shareholder from appointing separate proxies for shares appearing in each securities' account as
